



No.MUDRANK-2016/1335/CR No.365/M-1:- In exercise of the Power conferred by Clause (a) of section 9 of the Maharashtra Stamp Act, 1958 (LX of 1958) (here in after referred to as "the said act") the Government of Maharashtra being satisfied that it is necessary to do so in the public interest hereby remits in the whole of the State of Maharashtra, the stamp duty chargeable under the said act, on the instrument of Acknowledgement, Cash Credit Agreement, Deposit of Title Deeds, Pawn, Pledge and Hypothecation, Letter of Guarantee, Mortgage Deed, Guarantee of Debt or any other instrument relating to agricultural and crop loan up to Rupees 2,50,000/- for the period commencing on 1st April 2016 and ending on 31st March 2017 (inclusive of both days) executed by an agriculturist.

No.RGN-2016/1335/CR No.365(1)/M-1:- In exercise of the Powers conferred by section 78 of the Registration Act, 1908 (XVI of 1908) in its application to the State of Maharashtra, the Government of Maharashtra being satisfied that it is necessary to do so in the public interest, hereby amends the Table of Fees published in the Government Notification, Revenue and Forest Department, No. RGN.1558/677/1-N, dated the 17th July 1961, for registration of instrument and the same is required by section 79 of the said Act, as follows:-

In the said Table of Fees in Article I after Note 60 the following shall be added, namely:-

"Note 61- No Registration fees shall be chargeable on the instruments of Acknowledgement, Cash Credit Agreement, Deposit of Title Deeds, Pawn, Pledge and Hypothecation, Letter of Guarantee, Mortgage Deed, Guarantee of Debt or any other instrument relating to agricultural and crop loan up to Rupees 2,50,000/- for the period commencing on 1st April 2016 and ending on 31st March 2017 (inclusive of both days) executed by an agriculturist.
